Free School Meals / Pupil Premium

We receive pupil premium funding for children who are eligible for free school meals due to low income – see criteria below (not universal free school meals which all KS1 children are entitled to), children who have been adopted from care, and children with a parent in the armed forces.

If you believe any of these apply to your family please contact the office as soon as possible so that we may obtain the correct information from you.

Free School Meal Criteria:

Your child may be able to get free school meals if you get any of the following:

- Income Support
- income-based Jobseeker's Allowance
- income-related Employment and Support Allowance
- support under Part VI of the Immigration and Asylum Act 1999
- the guaranteed element of Pension Credit
- Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)
- Working Tax Credit run-on - paid for 4 weeks after you stop qualifying for Working Tax Credit
- Universal Credit - if you apply on or after 1 April 2018 your household income must be less than £7,400 a year (after tax and not including any benefits you get)

Children who have been adopted from care

- Please provide evidence of a care order / post looked after arrangements

Service Personnel with children

- at least one parent is serving in the regular armed forces (including pupils with a parent who is on full commitment as part of the full time reserve service)
- they have been registered as a 'service child' on a school census since 2016
- one of their parents died whilst serving in the armed forces and the pupil receives a pension under the Armed Forces Compensation Scheme or the War Pensions Scheme
